

Information and Incentives

The Walhalla City Council established the Economic Development Incentive Program in 2017. Contact the City Administrator for eligible projects and potential incentives, (864) 638-4343, or visit www.cityofwalhalla.com/departments/city-administration.

Pre-Application Meeting

The first step is to contact the Community Development office to discuss your project and schedule a pre-application meeting. Prior to submitting any permit applications or beginning any work, applicants must meet with the Community Development Team, including Community Development, Fire Marshal and Utilities Director to review the project, receive feedback and explain the approval process. Meetings are conducted at the proposed location. Call the Community Development office (864) 638-4343 or visit www.cityofwalhalla.com/departments/community-development.

Zoning

After the pre-application meeting has been held, applicants must file for a zoning permit. This is required for all new construction, structural additions/modifications or changes in business or use of the property. An approved zoning permit must be obtained prior to applying for building permits. The zoning permit will require contact information for the applicant and property owner (if renting), property information, description of the business/project and fee, and a copy of the lease (if renting). The Community Development office will determine if the proposed use is permitted based on the property's zoning and inform the applicant of any design standards that may be applicable.



Sewer Accessibility

A sewer accessibility and equivalency form may be submitted at the same time as the zoning permit application. This form must be submitted at City Hall. The Water Department will forward it to the Oconee Joint Regional Sewer Authority (OJRSA). The application includes property and business details, floor plan with seating layouts, plumbing plan and grease trap information, if applicable. OJRSA will evaluate the application and determine if additional impact fees are due. Applicants are encouraged to follow-up with OJRSA at info@ojrsa.org or (864) 972-3900 a week after submittal to discuss any additional requirements and/or arrange payment of any fees.

If you are proposing a food establishment, refer to OJRSA for their sewer use regulations.

Fire Inspection

Once all structural work has been completed and you are ready to occupy the space, schedule a fire inspection with the Fire Marshal. The Fire Marshal's approval is required before the connection of utilities or request for a business license. Call Walhalla Fire Department at (864) 638-4345 to schedule.

If you require temporary water service for renovation work, contact the Fire Marshal for approval.

Utility Connection

Once the Fire Marshal has given approval, you can apply for utility services with the City at City Hall. You will need a government issued ID, copy of lease/deed, copy of OJRSA approval and fee.

This is also the time to determine you business's sanitation needs. If roll carts or a dumpster will be require to accommodate your needs, this is the time to make those arrangements. If you choose to have dumpster you must place it upon a concrete pad.



Hospitality Tax

If you are starting a business in the food industry, you will need to complete the city's form for Hospitality Taxes. The collection of a 2% hospitality tax was enacted by SC state law and city ordinance in 2012. This tax is collected on all prepared food and beverage and is used to promote tourism inside the City of Walhalla. Visit www.cityofwalhalla.com/hospitality-tax/.

Signage

A sign permit is required before a business may erect a sign. All signs must adhere to the City's Sign Regulations. If your business will be located in the Downtown Business District, the sign must meet the Downtown Design Guidelines. The permit application and supporting documentation is submitted to the Community Development office. The form includes property information, business information, type of sign, colors and materials of the sign, contractor's information and fee. For freestanding signs, you must provide scaled and sealed drawings with placement location, prepared by an engineer. Visit www.cityofwalhalla.com/departments/codesand-zoning/.

Business License

All individuals and businesses operating within the municipal boundaries of the City of Walhalla is required to obtain an annual business license. Fees are based on the rate class associated with the North American Classification System (NAICS). Business license renewals may be conducted online. Visit www.cityofwalhalla.com/business-license/.

Grand Opening

Congratulations! You are now ready to officially open your business. You are encouraged to contact our Main Street Walhalla (MSW) office to schedule a ribbon cutting to announce your opening. Communicate your events and promotional opportunities with MSW to help spread the word. If you plan to hold a special event or grand opening, contact the Community Development office on special permissions for additional temporary signage to help you promote your opening or future event. Business Resources

Accommodations

If your business rents accommodations, including vacation homes, for fewer than 90 consecutive days to the same customer, you must collect and remit a 2% accommodations tax in additional to the 5% sales tax to the SC Department of Revenue. If you provide accommodations for more than one week in any quarter of a calendar year, you will also need a SC Retail License. Visit www.dor.sc.gov.

Short-term rentals must register with Oconee County through the Online Payment Portal and Registration link; and collect and remit the local accommodations tax by the 20th of each month. Visit https://oconeesc.com/pay-taxes-home/accommodations-tax.

Alcohol

Businesses that sell or serve alcohol must obtain a permit from the South Carolina Department of Revenue's Alcohol Beverage Licensing section. Businesses that serve alcohol by the drink must also collect and remit a liquor by the drink tax. Call (803) 898-5864, or visit www.dor.sc.gov.

Annexation

Property owners of parcels contiguous to City limits may request an annexation by filing a petition signed by owners to the City Administrator. After Planning Commission's review, Council must pass an ordinance with two readings and a hearing to annex the property.

Business Names and Trademarks

Prior to publicizing and circulating the name of your business and/or logo, check its availability with the SC Secretary of State to assure it is not already in use in SC. To trademark your business's name, register it with the Secretary of State's Trademarks Division. Call (803) 734-0629, or visit www.sos.sc.gov.

Facade Grants

The Community Development Façade Grant is a reimbursement grant of up to 50% of the project with a maximum grant of \$3,000 per property per twelve-month period. At this time, eligibility is limited to buildings or structures located within the Downtown Business District Overlay. Business Resources

Food Industry

Businesses that handle food, including restaurants, grocery stores and convenience stores, must first obtain a license from the SC Department of Health and Environmental Control (SC DHEC) prior to operation. Call the Upstate Walhalla Office at (864) 638-4185, or email BEHS-Walhalla@dhec.sc.gov.

Food Trucks

Food trucks, carts or other mobile food businesses must apply for and receive approval from the City's Community Development office before applying for a business license. Call (864) 638-4343, visit www.cityofwalhalla.com.

Hospitality

Restaurants, bars, clubs, coffee shops, bakeries, delis and other businesses that prepare, serve, repackage, or sell food or alcohol within City limits are required to collect and remit a 2% hospitality tax to City Hall each month. Incorporation

To incorporate your business, contact the South Carolina Secretary of State at (803) 734-2158, or visit www.sos.sc.gov.

Retail

If your business sells items at the retail level, it must obtain a retail license and collect and remit sales tax to the South Carolina Department of Revenue. Call (864) 241-1200 (Greenville) or (803) 898-5000 (Columbia), or visit www.dor.sc.gov.

Tobacco

Businesses that sell tobacco products must obtain a license from the South Carolina Department of Revenue. Call (803) 896-1970, or visit www.dor.sc.gov.

Submittal Procedures

No permit applications may be submitted until after the Pre-Application Meeting.

Please submit forms, fees and any supporting documents to the appropriate department, in the following order.

- Zoning Permit Community Development, City Hall
- Sewer Accessibility/Equivalency Form Front Counter, City Hall
- Fire Inspection Call Fire Marshal to schedule
- Utilities Contract Front Counter, City Hall
- Hospitality Tax Front Counter, City Hall
- Sign Permit Community Development, City Hall
- Business License Front Counter, City Hall

Fees may be paid by cash, check or card.

Online or over the phone payments are not accepted.

Businesses located within the Downtown Business District are subject to the Downtown Design Guidelines.

If you are starting a food business, please contact SC DHEC for any required permits prior to fire inspection.

If you plan on building, expanding or other alterations, a Zoning Permit is required to obtain Building Permits.
